\*\* As a result of admitting excess students in MD (Anaesthesia) & MD (Paediatrics) during 2011-12, the Dean has executed affidavit vide reference 6<sup>th</sup> cited, to the effect that one seat each in aforesaid two specialties will be reduced while making admissions for the year 2012-13.

\*\* As such one seat each in MD (Anaesthesia) & MD (Paediatrics) are hereby reduced out of 4 (four) seats permitted by MCI. The Dean is therefore informed to make admissions only for 3 (three) seats each in MD (Anaesthesia) & MD (Paediatrics) for the academic year 2012-13.

The Admissions shall be made under the rules prescribed by the Govt vide G.Os. In the reference 1<sup>st</sup> to 3<sup>rd</sup> cited.

The management of college is directed to follow the various instructions issued from time to time by the Govt. of AP / Dr. NTR UHS, Vijayawada in respect of admissions, tuition fee to be collected and other related issues. Number of students admitted shall not exceed the number of seats permitted by Dr. NTR UHS for annual admissions.

The fee collected by whatsoever name called either for University seats or for management seats shall not exceed the limits specified by the Government of Andhra Pradesh / NTR UHS from time to time.

The management of the college shall follow the regulations made by the University / Government of Andhra Pradesh in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation, in this regard may lead to disaffiliation of the college without any notice.
