

In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Renewal of Recognition of MS(General Surgery) qualification for 02 seats in respect of students being trained at Shadan Institute of Medical Sciences, Teaching Hospital & Research Centre, Hyderabad under Kaloji Narayana Rao University of Health Sciences, Warangal, Telangana**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- (ii) *The procedure for 'Renewal of Recognition' shall be same as applicable for the award of recognition.*
