

I am to state that the General Body of this Council at its meeting held on 22/11/2016 considered the Compliance Verification Assessment Report (18/04/2016) along with the Council Assessor's Report (May, 2014 & November, 2014 for 2 degree & 1 diploma seat and May, 2015 for 2 to 3 seats & 05.10.2015 for 2 degree and 1 diploma seats) and compliance dated 20/01/2016 submitted by the college authorities on the physical and other teaching facilities available at Shadan Institute Of Medical Sciences, Hyderabad for the award of MD/MS(OBG) qualification for 03 seats & DGO qualification for 01 seat under Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh. The Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (18/04/2016) along with the Council Assessor's Report (May, 2014 & November, 2014 for 2 degree & 1 diploma seat and May, 2015 for 2 to 3 seats & 05.10.2015 for 2 degree and 1 diploma seats) and compliance dated 20/01/2016 submitted by the college authorities and decided to recommend to the Central Government that MD/MS(OBG) qualification for 03 seats & DGO qualification for 01 seat granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Shadan Institute Of Medical Sciences, Hyderabad be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.
