As per permission accorded vide Lr.No. U.12012/127/2004-ME (P-II), dt. 11-07-2006 by the Ministry of Health and Family Welfare Department of Health Government of India., New Delhi, and as per the orders of the Vice-Chancellor, Dr. NTR University of Health Sciences, vide reference 4th cited, and as per statute on affiliation of Medical Colleges of Dr. NTR UHS., Vijayawada, it is hereby certified that the application of Shadan Educational Society, Hyderabad for granting provisional affiliation for starting of 2nd year MBBS Course during the academic year 2006-07 has been registered with the Dr. NTRUHS., and provisional affiliation is granted for starting of 2nd MBBS Course with 100 students and also permitted for making admissions during the academic year 2006-07 with an intake of 94 students only as per rules.

The No.of students admitted do not exceed the number of students permitted for annual admissions both under free and management quota as specified by the Government of Andhra Pradesh / Dr. NTR University of Health Sciences.

The fee collected by whatsoever name called either for free seats or for management seats do not exceed the limits specified by the Government of Andhra Pradesh / Dr. NTR University of Health Sciences from time to time.

The management of the College shall follow the regulations made by the University / Government of Andhra Pradesh in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation, in this regard may lead to disaffiliation of the college without any notice.
